ADMISSION REQUIREMENTS

First Year and Second Year Direct (SYD) applicants must meet the following admission requirements:

1. A minimum of three years in the banking industry or in a closely-related financial field.
2. A baccalaureate degree or compensating experience.
3. A recommendation from an executive officer of a taxable, financial institution or its holding companies, affiliates or regulatory agencies.

An applicant may be admitted as a Second Year Direct (SYD) student if the individual has achieved one of the following admission requirements*:

1. A Graduate Degree, such as an MBA, JD, or MS Finance.
2. A Professional Certification such as a CPA, CFP, or CFA.
3. A Bachelor's Degree plus a diploma from one of several approved banking schools.

*Transcripts of your graduate degree, a copy of your diploma, and/or copy of the professional certification must be provided.

By submitting this application, the applicant grants the Graduate School of Banking at Colorado (GSBC) permission to:

1. Contact his/ her employer to discuss academic progress at GSBC.
2. Reveal to his/her employer all information about the candidate that GSBC considers relevant for that purpose.

FEES AND REFUND POLICY

Applications received that are incomplete or that do not include the required non-refundable processing fee of \$200 will not be considered. Completed applications will be reviewed and admission decisions will be made within two weeks of receipt of application. You will be notified by mail of your acceptance decision.

Tuition for both one-week Computer-Based Education (CBE) online and two-week resident students to attend the July 12-24, 2009 School session is \$3,445 plus a non-refundable processing fee of \$200, and will be invoiced after acceptance. Total fees are due upon receipt of invoice and no later than April 30, 2009. A graduation fee will apply in your third year of GSBC.

A Student who withdraws from the session after May 15, 2009 will be charged an additional \$250 cancellation fee. If the withdrawal occurs after June 8, 2009, one-half of the tuition will be retained. For withdrawals after July 6, 2009, tuition and all applicable fees will be retained.
